- 9 PD account system is availed for the clients for ease of transactions.
- 10 It is presumed that all consignments (Import/Export) being received at CFS are adequately insured against possible risk during transportation & storage & the company assumes no liability in this respect. Incase if the insurance is not covered by consignee/shipper they have inform us in advance to cover insurance by us for which charges will be recover from consignee / shipper.
- 11 Prior gate in of Cargo/Container, all CFS dues should be paid upfront.
