For movement of Export Containers to Terminal, the CFS must be allowed minimum 72 hours of time after completion of stuffing of last container and completion of customs formalities and receipt of Form 13 issued by the liners. We CFS are not liable to pay any shut out, or holding charges incl any SSR charges levied by Terminal.
3. Additional charges will be levied for cargo requiring special services like, lashing, materials etc. on case-to-case basis
4. Any Over time charges, if required to paid to Customs, concerned Shipping line / CHA will have to pay the prescribed charges.
5. All cheques / DD to be drawn in favor of " VISAKHA CFS & LOGISTICS PRIVATE LIMITED" Payable at par all branches. PI collect the Cash Receipts for Cash payments made.
6. PD account system is availed for the clients for ease of transactions.
7. It is presumed that all consignments (Import/Export) being received at CFS are adequately insured against possible risk during movement & holding & the company assumes no liability in this respect. In case if the insurance is not covered by consignee/shipper they have to inform us in advance to cover insurance by for which charges will be recovered from consignee / shipper.
8. Prior gate in of Cargo/Container, all CFS dues should be paid upfront.
9. GST & other government levies shall be applicable at the prevailing rates at the time of billing.
