7. Shipping line / CHA will be requiring to pay Customs Overtimes, if any required work done at ICD.
8. All cheques / DD to be drawn in favor of "Sattva CFS and Logistics Private Limited" Payable at par at all branches. Cash payments only against Cash Receipts.
9. PD account system is availed for the clients for ease of transactions.

It is presumed that all consignments (Import/Export) being received at ICD are adequately insured against possible risk during transportation & storage & the company assumes no liability in this respect. Incase if the is not covered by consignee/shipper they have inform us in advance to cover insurance by for which charges will be recover from consignee / shipper.
11. Prior gate in of Cargo/Container, all ICD dues should be paid up front.
